EDITORIAL

This is the tenth anniversary issue of AMERC NEWS under my editorship. Too much in our profession has been introduced by diktat and I thought this was a good example of the Association as a 'learning organisation.' – more management speak!

Recently I have noticed that the website has become a valuable source for centres, students and the informed public. AMERC NEWS and the website are complementary; the website material is quickly amended with circumstances and the Announcements Page provides rapid communication. It strikes me that the homilies we see from the Chief Examiner reminding REC Coordinators of their obligations for examiners and staff to be conversant with the content of AMERC NEWS should stretch to include monitoring the website for urgent news and announcements.

THE ASSOCIATION'S CHAIRMAN

Directly after AGM, using the new Rules that had been agreed, the Executive Committee met and voted Mike Webster in as Chairman. This will be popular appointment and we all look forward to working with Mike in the next year.

AGM 2009

The Association's AGM and Examiners' Panel were held in the Marriott Hotel, Glasgow, on Thursday 28 May 2009. There were thirty-eight delegates and sixteen had apologised for non-attendance.

The Chairman explained the proposed changes to the Rules of the Association which had been published with the AGM papers. Change was needed to match the Articles of Association of the company, its charitable status and some aspects of its operations.

The new Rules, which were approved, provide for AGMs to elect an Executive Committee of six with its own powers to elect a Chairman and Vice Chairman from among its membership. Members of the Executive Committee are to rotate on a triennial basis.

At this meeting Philip Davies, Kevin Walsh and Terry Slack were elected as Directors of AMERC Ltd and as Ordinary Members of the Executive Committee.

FINANCE

MARITIME CONSULTANCY GROUP (MCG) WITH MATTERS FROM THE EXAMINERS' PANEL (1)

The MCG met in Kendal in March and before AGM in May, giving attention to the usual mix of operational matters. With the following report of some of the matters are some similar items dealt with at the Examiners' Panel.

DYSLEXIA POLICY

We reported in the last Issue that the Executive Committee had agreed 'small but significant changes' to the Association's policy for dealing with GMDSS Examination candidates who suffer from dyslexia.

The amended text of the policy has been incorporated in the latest version of the Examination Administration Handbook (8th Edition 2009 Rev.1) which can find on the AMERC website. It appears in Section 12, the Appendix, on page 73.

SART & EPIRB EQUIPMENT FIT

From 1st June 2009, all Centres must ensure that they have at least two 406 MHz dummy EPIRBs and two 9 GHz dummy SARTS for training and examination purposes.

This too has been incorporated into the latest version of the Examination Administration Handbook. You will find it on page 20 in Section 4, – Equipment Requirements for Examination Centres.

DOUBLE MARKING

Here is some clarification on double marking given at the Examiners' Panel. A *second* marker may be a listed Examiner who has taught candidates on the course.

FLEET 77

The Examination Administration Handbook has been amended to incorporate Fleet 77 in various places. It appears as a requirement to have or use 'Inmarsat-B/Fleet 77 terminals or approved simulators.'

QUESTION BANK

Kevin Walsh led a discussion at AGM on developing a question bank for display on the AMERC website. The response from delegates was that this was felt to be a valuable training tool.

As a consequence, the principle was adopted and referred to a working group led by the Chief Examiner. Reports on its progress will be published from time to time in AMERC NEWS

LRC & ROC SYLLABUS

Amendments to the LRC syllabus and that of the ROC have followed the new requirements arising from WRC07 and examination papers will incorporate the changes from 2010. In the meantime the LRC and ROC marking schemes have been adopted to include the use of MMSI in Distress, Urgency and Safety calls.

Candidates will be expected to include reference to MMSI in their answers to demonstrate that they are aware of the correct procedure

MARITIME CONSULTANCY GROUP (MCG) WITH MATTERS FROM THE EXAMINERS' PANEL (2)

ITU MANUAL AWAITED

It is anticipated that the ITU Manual of radio regulations, revised to incorporate WRC07, will soon be published.

The Densham Associates' site (www.gmdss.com.au) has a page giving some indication of what it will contain, incorporating a link to the ITU Committee documentation.

It includes references to the retention of 2182 kHz for marine use and the the change of use for 500 kHz. There is expected to be simplification of the carriage requirements for mandatory ITU documents by 2011 including the elimination of the List of Radiodetermination and Special Service Stations.

We hope to publish further information in the next edition of AMERC NEWS.

PHAROS SIMULATOR APPROVED

The Association has approved the use of the Poseidon Pharos GMDSS Simulator, Version 6.0.3 for tuition and examinations. The conditions of use mirror those of the approved Transas GMDSS Simulator.

For further details of the conditions and requirements of approved simulators, refer to the 8th Edition of the Examination Administration Handbook on the AMERC website, page 20, Section 4

FAULTY EQUIPMENT

Given that the new OPT examination is student-led, if an item of equipment develops a fault during the examination, the Examiner must stop the process.

The examination should only be resumed once the fault has been cleared. Due allowance must be made for 'time lost' in such circumstances.

ALRS

Each REC must provide for the Examinations a set of ALRS documents that are compatible with the new OPT scenarios. The publications, Volumes 1, 5 and all parts of 6, that meet this requirement are those issued since 2005.

This matter is likely to receive further attention at the MCG.

EC APPOINTMENTS

The Executive Committee has appointed Kevin Walsh and Phil Davies as the AMERC representatives on UKCOM and the MNTB Technical Committee respectively.

Phil Davies' report to AGM makes interesting reading as it forecasts some developments with ETO training and short course guide revision.

A block diagram showing the structure of the courses appears on the following page.


AMERC WEBSITE

ADMINISTRATION

REC Coordinators are asked to note the following and to communicate them as needed with their Centre staff and examiners.

CERTIFICATE REPLACEMENTS

In cases where replacement certificates are needed, the applicant should complete the form for that purpose. The form, with descriptions of procedures, may be obtained from the AMERC website.

It should be noted that the cost to an applicant who requires the despatch of a certificate by courier outside of the UK is currently £stg. 30.00. This is subject to review and the latest position should always be checked before submitting a completed form.

MCA ENDORSEMENT

Candidates for GMDSS examinations other than LRC must be made aware that until the MCA has endorsed the certificate it is not valid for use onboard ship. (MCA endorsement is an STCW requirement which is why it does not apply to LRC).

PHOTOGRAPHS

From 1st June 2009, all candidates for GOC, ROC and LRC examinations must provide photographs of themselves that comply with the UK Passport Office requirements. One easy way to determine what these are is to go to the Directgov ('public services all in one place') website:

REVISED OFFICIAL TITLES

Members and associates are asked to note that the Association's official title is as follows:

Members are also asked to note that the titles Honorary Secretary and Honorary Treasurer have been replaced by *Secretary* and *Treasurer* respectively. All members are asked to use the revised titles from now on.

A CASE FOR DIRECTION FINDING AT 406 MHz

The Chief Examiner has sent the Editor a paper presented to COMSAR a year ago by the United States. It argues a powerful case for the installation of 406 MHz direction-finding installations within SAR systems and urges other administrations to do so.

It illustrates the advantages of moving homing signals from 121.5 MHz to 406 MHz. In the latter case the data burst is two hundred times stronger and US Coastguard studies have shown that aircraft flying at a height of 25,000 feet can detect signals up to 150 nautical miles from the source of transmission. It criticises 121.5 MHz transmissions for their tendency to be attenuated by the environment including the shielding effects of the human body.

Two case studies are cited in the paper, one of which graphically illustrates the value of the 406 MHz direction finder. It says that:

On 12 June 2005, ten separate USCG aircraft flew 18 sorties that covered 13,118 square miles to locate a 10 meter pleasure craft 26 NM off the coast in the Atlantic Ocean. After thousands of miles of cumulative search effort, a USCG C-130 equipped with a prototype 406MHz DF was launched. While still 90 NM from scene, at 17,000 feet, the new 406 MHz DF equipment locked onto the 406 MHz beacon signal. The C-130H aircraft flew directly to the new electronic intercept solution and located two survivors clinging to the bottom of their overturned craft. An HH-65 helicopter was vectored to their position and hoisted the two survivors to safety. They had been holding onto the bottom of their capsized catamaran for over 24 hours.

The paper goes on to argue that more rapid fixes provide savings in search aircraft fuel that outweigh the installation costs. The USCG is adding a 406 MHz direction finder/homing facility to its VHF communication system (Rescue 21) which is to cover all 28,000 miles of the US coastline and eighty-nine US Coastguard aircraft are to be fitted by 2012.

The paper concludes by recommending other states to follow the example of the US, Canada, Germany, Malta, Australia and the UK in their direction finding installations.

US AIS

The US Coast Guard is investing US\$12 million in an Automatic Identification System data exchange capability that will cover the whole of the US. The intention is to produce a system that will allow the exchange of information between AIS fitted ships and aircraft, aids to navigation and shore stations across the ports, waterways and coastal areas. It has security as well as safety implications.

MGN 395 (M+F) NEW RADIO LOG BOOKS

The GMDSS Radio Log Books have been merged into a single document called 'The GMDSS Radio Log Book incorporating the Simplified F/V GMDSS Log Book.'

This Guidance Note reviews the requirements for entries and gives an example of a completed page. The Note replaces MGN 288 and it has some importance for AMERC Members.

May 2009

MGN 392 (M+F) RADIO SURVEY AUTHORISATIONS

Selex Communications no longer provides radio survey facilities for UK ships and this Guidance Note reviews the new arrangements.

It indicates that vessels in class, except passenger ships and fishing vessels will be certificated by UK-recognised classification societies. Other vessels including emergency response and rescue craft and those unclassed will be surveyed by persons authorised by MCA.

This Note, which replaces MGN373 (M+F) explains the procedures and gives relevant addresses.

May 2009

MSN 1735 (M+F) AMENDMENT 3 TYPE APPROVAL

This Merchant Shipping Notice updates the list of equipment for which no agreed international testing standards exist. Further advice is expected from the EU and in the meantime this list is intended to help.

It contains the updated list of UKdesignated bodies that are approved to undertake type approval.

MIN 347 (M+F) STANDARD PHRASES

This Marine Information Note reminds its readers that the ability to employ standard Marine Communication Phrases is mandatory for officers in charge of navigation watches on ships of 500 gt or above.
