The **quarterly statistics for GMDSS examinations** from the NAC are also included here.

The **Maritime Consultation Group (MCG)** meets regularly - currently four times each year – for the AMERC Executive Committee ‘Open Meeting’. MCG membership consists of AMERC Executive Committee (EC) representatives; the AMERC Chief Examiner; the MCA Chief Examiner and/or the MCA Deck & GMDSS Team Leader; the NAC and other AMERC/industry specialists.

The latest meeting was held in Liverpool in conjunction with the Annual General Meeting (AGM) and Examiner’s Panel, in June 2015. The following items reflect discussions at MCG (full minutes will be circulated appropriately), AGM and Examiner’s Panel - and/or associated items that are of interest to Members and training centres. The items are placed according to size - not in any ‘priority’ order.

Inmarsat Presentation: John Dodd of Inmarsat gave a presentation on the future of Inmarsat services, with the emphasis on how delivery of Maritime Safety Information and other Distress and Safety services are being developed. Of particular interest was the ongoing development of a future system that will perform various Distress and Safety functions required by the GMDSS - whether using Inmarsat-C, Fleet Broadband or the Global Express (GX) service.

Approved Simulator Changes: The AMERC Administration Handbook has been updated to include additional approved GMDSS simulators. This update also clarifies where networked and/or stand-alone ‘tutor’ simulation is allowed. The revised handbook can be downloaded by Members and approved centres. Non-members can apply online for a copy of the Handbook (for a small administration fee).

Classroom and Examination Centres – Publications Requirement: The Chief Examiner emphasised the different requirement for course delivery - where more than one set of publications are required; and examinations - where a single set is required. The different requirements are clearly listed in the AMERC Administration Handbook.

Chief Examiner and Secretary Appointments: Keith Mitchell was appointed for a further 3-year period as Chief Examiner; Terry Slack was appointed for a further 3-year term as Secretary.

MNTB Short Course Criteria – GOC and ROC: The MNTB Short Course Criteria for GMDSS GOC and ROC have now been updated and approved. They will be available from the MNTB in the near future. Noted that the **normal Instructor:Student ratio is 1:8**. It has been agreed that this may be extended on a case by case basis up to a maximum of 12-per-instructor - where supported by additional equipment fit and appropriate course structure. The course structure must ensure that all trainees are fully engaged in meaningful learning activity throughout the course.

The **contact-hours** requirement remains as previously and across all MNTB approved programmes - and is for not-more than 8-hours over a period of 10 in any one working day. Centres may exceed the 8 (e.g. to provide additional, supervised, equipment time) – but cannot count that additional time towards the required (contact hours) total (e.g. GOC – total minimum course length is 60 hours, with 2.5 hours allowed for exam time, giving a minimum contact time of 57.5 hours).

MSN 1864 (M): The MCA has replaced MGN 214 with [MSN 1864 \(M\) ‘Training and Certification Guidance: UK Requirements for Radio Operators’](#). A notable change appears to be the requirement of all Bridge Watch-keepers operating outside of Sea Area A1 to hold a GOC (MGN 214 required that a GOC-holder had to be onboard - allowing other Bridge Watch-keepers to hold a ROC).

AGM 2016: The next AGM & Examiner’s Panel date is 15th-16th June 2016 - venue to be advised.

Explanation Please?

This is the area for questions that may puzzle you – whether you're a trainer without a specific 'radio' background; a seagoing operator who's finding that the 'real world' doesn't seem to be fully in tune with what you learned in the classroom (or with what you've read in publications – official or otherwise); or because it's not particularly clear why a specific answer to an examination question is necessary when it appears that other answers may also appear appropriate. *Note that those of you who have access to our 'EXAMINER'S FORUM' on the AMERC website can open-up and discuss any subject/question that they have an issue with 😊*

The exchange below reflects a question raised by a delegate at one of our AMERC-approved overseas centres, during a GMDSS GOC course.

Question: One of our delegates has asked a question regarding sending messages from an office ashore, to a vessel at sea, when using Inmarsat. Can you send me info on how this can be done by using TLX or by email? Would the shore-based office have to register for the service with a Land Earth Station Operator (LESO)?

Answer: Registering is required to send email messages shore-to-ship - but not for TLX (telex). To send telex (TLX) messages to an Inmarsat-C or –B terminal, the message is sent (from a telex terminal in the office) to the Inmarsat mobile number – using the Inmarsat telex 'country code' followed by the Sat-C/Sat-B ID number, e.g.

AORE +581 (then the Sat-C/B vessel ID)
POR +582 (then the Sat-C/B vessel ID)
IOR +583 (then the Sat-C/B vessel ID)
AORW +584 (then the Sat-C/B vessel ID)

There is no 'telex' service on Fleet services.

For Sat-C email, someone who holds an Inmarsat account (or who is prepared to open an account) can [register for the 'C-email' service](#). The registration form allows you to list the email addresses that you are prepared to accept charges for – or to use 'username and password' authentication. This C-Email service is provided by STRATOS LESs.

A similar to-ship (Inmarsat-C) service is provided by the [Airbus Defence & Space 'MARLINK'](#) gateway, using a network of LESs to give full Inmarsat Ocean Region coverage. Information about this service – including how to register – is available by email from asbc.customercare@astrium.eads.net

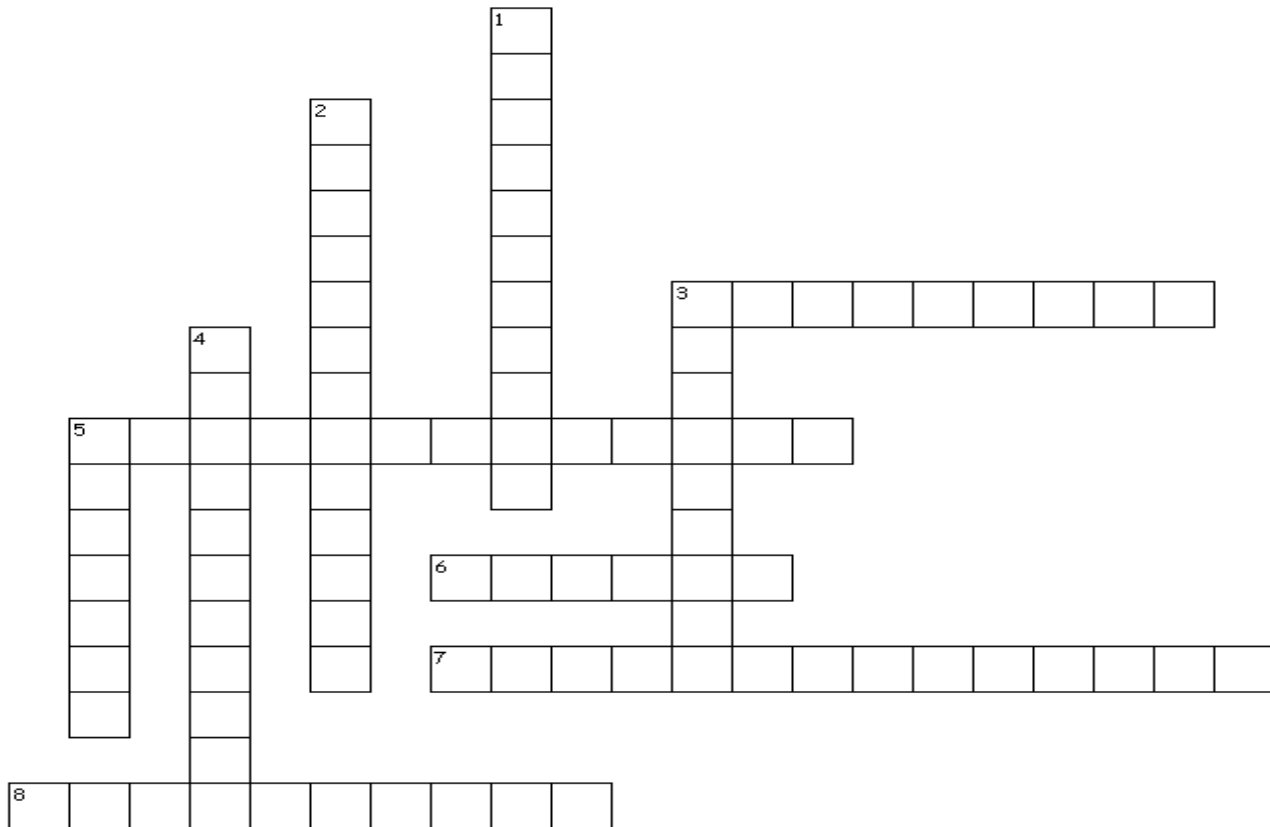
Other LESOs may offer Inmarsat-C email services – use the 'Land Earth Station Operators, Contacts and Services' section of ALRS Volume 5 for customer services points of contact.

For messaging to Fleet 77, the terminal has a data ID (in addition to its telephone number) and can be effectively 'connected' to the office Local Area Network.

To use email over Fleet Broadband, [download the guide](#) from Inmarsat and/or contact your preferred LESO - who may be able to advise on messaging software like ['SkyFile Mail'](#) - designed to optimise throughput using satellite links.
