## Editorial

In this issue we also have our usual brief on the most recent **Maritime Consultation Group** (MCG – Page 2), and which includes the appointment of the new **Company Secretary**, and a note about the possibility of centres receiving **unannounced visits by the Chief Examiner**, and the circumstances that might generate such a visit.

There's also a note about the availability of a **training video for our RT Exercise (GOC)** on the AMERC 'resources' area of our closed website.

Reporting of NAC **quarterly statistics for GMDSS examinations** has been replaced by an **annual rolling report** on exam statistics – this edition of the News showing the first table using the new format.

The **Maritime Consultation Group** (MCG) meets regularly - currently four times each year – for the AMERC Executive Committee ‘Open Meeting’. MCG membership consists of AMERC Executive Committee (EC) representatives; the AMERC Chief Examiner; the MCA Chief Examiner and/or the MCA Deck & GMDSS Team Leader; the NAC and other AMERC/industry specialists.

The latest meeting was held in London in September 2018. The following items reflect discussions at MCG (full minutes will be circulated appropriately) - and/or associated items that may be of interest to Members and training centres. The items are placed according to size - not in any ‘priority’ order.

**Company Secretary Change:** Following the retirement of Terry Slack as company secretary, three applications for the post were received and interviews held, resulting in the appointment of Prue Langfield to the post. Prue will be located at the AMERC NAC. There is no change to the Secretary’s email address, which can be found on the ‘contacts’ page of the AMERC website.

**RT Exercise – GMDSS GOC Examination:** Kevin Walsh of Warsash/Southampton has prepared an example RT exercise/log keeping video which can be accessed via the ‘resources’ section of AMERC website (login required to view the ‘resources’ page). Note also that:

- there is now an expanded list of approved abbreviations that may be used in the RT radio log - displayed at the end of the video; and that
- those who may wish to use this with their students but do not have a good classroom Internet connection, should contact Kevin directly at [admin@amerc.ac.uk](mailto:admin@amerc.ac.uk) – requesting a copy for offline use.

**Chief Examiner – unannounced visits:** Centres are reminded that the Executive Committee may authorise unannounced audit visits of centres where concerns have been raised over their ability to function in accordance with AMERC guidelines – e.g. a notable change in results achieved; or adverse feedback from staff or clients. AMERC Administration Handbook (Section 2.6.7.1, Para’s f and h, refer)

**New Series (2019-2020) Exam series update:** It is expected that the forthcoming 2019-2020 series examination papers will be available to view and download by authorised users, with effect from 1<sup>st</sup> November 2018. This should allow centres adequate time to prepare for their introduction on 1<sup>st</sup> January 2019.

**AGM 2019 and Examiners’ Panel:** Next year’s AGM & Examiner’s Panel will be held on Wednesday May 22<sup>nd</sup>, – followed by the AGM dinner. More detail on venue will be provided direct to Members in due course.

# COASTAL RADIO

*The huge loss of life on the Titanic shocked the world. As a result of the disaster, the first International Convention for Safety of Life at Sea (SOLAS) was called in London in 1913.*

This brokered an international agreement which, among other things, introduced uniform radio communications between ships and from ship to shore.

Coastal Radio Stations were set up to monitor ships' radios. In Australia, by 1914, the government had increased its Coastal Radio Stations from three to fifteen. One of these was in Townsville.

The Townsville Coastal Radio Station opened on the edge of Victoria Park in South Townsville on 7 August 1913. It had two broad functions. One was the non-profit SOLAS, or Safety of Life at Sea – a coast watch service for the treacherous waters off Townsville and the Great Barrier Reef. The other was the commercial operation of radio telephone, telegrams and ship to shore 'phone calls.

The federal government sold the Coastal Radio Stations to Amalgamated Wireless (Australasia) Ltd (AWA) in 1920 but bought back a controlling interest.

As time went on the Townsville station acquired other functions. These included receiving weather reports from the Willis Island meteorological station, receiving mail messages transmitted by AWA staff on Willis Island and acting as a relay station for Thursday Island and Cooktown radio stations. After 1931 Townsville replaced Cooktown as the main relay station for messages from New Guinea to Sydney.
