EXAMINERS' HANDBOOK

There is some hope that the Examiners' Handbook will be ready by the beginning of 2008.

ASSISTANT CHIEF EXAMINER

Francis Rodrigues of TS Rahaman has been appointed as the Association's Assistant Chief Examiner (Overseas), having specific responsibility for the Indian sub-continent and Sri Lanka.

TRANSAS SIMULATOR

Returning to discussions on the Transas TS4100 the MCG decided that a centre fitted with such an installation would be required to fit a live receiver. A work station for each student is the preferred arrangement and where R/T simulation is used it will be essential.

REC Coordinators are reminded that they have the responsibility to maintain an 'Active List' of GMDSS Examiners for their Centres.

MNTB TECHNICAL COMMITTEE

Continuing a long AMERC tradition, the Association is represented on the Merchant Navy Training Board (MNTB) Technical Committee. This is an important role currently occupied by Phil Davies of the Lairdsie Maritime Centre. Phil provides each MCG with an update on events at the Committee and we hear that the Committee is currently engaged in discussing educational and training requirements for Electro-technical Officers, ETO. This must be an opportune time, given the number of advertisements for that rank in the Nautilus UK Telegraph.

SCENARIO BASED OPT

A trial has been conducted at TS Rahaman and another is expected at South Tyneside College. AMERC NEWS will bring you details of the outcomes when they are available.

RESULTS SHEETS

Sue has requested that examiners (including second markers) clearly identify themselves on the Results Sheets by putting their initials in upper case letters and not in script.

This will make for easier checking, an important part of the QA process.

AMERC WEBSITE

Kevin Walsh gave the MCG a progress report on the design of the new website. The pages now have a pleasing and professional look to them which will be to the credit of the Association.

We will give details at a later date but one feature worth noting is that there is an intention to make the website useful for enquiries from candidates and prospective students.

OPT EXAMINATIONS SAT-A WITHDRAWAL

Centres are reminded: the INMARSAT-A system will be switched off at one minute before midnight on 31 December this year. GMDSS compliant INMARSAT-B will replace SAT-A in the OPT Examinations from 01 January 2008.

In the last Issue (24) we said that Fleet 77 installations could be used for the OPT from the beginning of 2008. ***This is incorrect.*** Its introduction awaits further work by the Examiners' Panel.

History buffs will remember that SAT-A was introduced in February 1982, the first service to be delivered by INMARSAT. At its peak there were more than 18 000 terminals in use. It has had a good innings.

M-NOTICES (1)

The following M-Notices appear to have some relevance to Members. The full list of the current M-notices appear on the MCA website (www.mcga.gov.uk) to which reference should be made from time to time. Seemingly a number of these are of significance to national and international Members of AMERC.

MSN 1816 (M+F)

EPIRB REGISTRATION

This Notice gives a reminder of the provisions in the Merchant Shipping (EPIRB Registration) Regulations 2000. In particular it advises users that 406 MHz beacons must be registered and that any changes to are to be notified. Homilies about jeopardising SAR are given and the legal penalties spelled out.

The registration and quarterly monitoring processes by the authorities are explained.

Although much of this Notice may be stating the obvious to AMERC members, it provides course material.

MIN 301 (M)

LRIT REQUIREMENTS

A new addition to SOLAS Chapter V requiring Long-Range Identification and Tracking of Ships (LRIT) comes progressively into force from 01 January 2008. A ship will be required to transmit its identity, position, date and time at regular intervals. This is intended to assist SAR, safety and environmental protection. Exceptions include AIS fitted ships solely trading in A1 Areas and cargo ships of less than 300 gt.

MGN 349 (M+F)

RADAR REFLECTORS

This Guidance Note summarises some of the environmental and physical factors that can degrade radar detection. It refers to the provision in SOLAS Chapter V which requires vessels of less than 150 gt to have X and S Band reflectors – if practicable.

The Note recommends yachtsmen to have a permanent installation of a reflector device of the best possible type (examples are given).

It also refers to the MAIB Report in respect of the loss of the yacht 'Ouzo' and gives links to the Report.

MGN 350 (M+F)

SHORE-BASED

MAINTENANCE

This Note gives details of a set of requirements that must be met by any company offering shore based maintenance (SBM) of GMDSS equipment.

Four annexes to the Note specify the requirements to be met by SBM companies including the qualifications of service staff. Details of registration processes are included.

M-NOTICES (2)

MGN 345 (M) 'ALTERNATIVE COMPLIANCE'

This Guidance Note describes the Alternative Compliance Scheme (ACS). The Scheme aims to streamline processes of survey and certification while maintaining standards. It is also intended to minimise potential duplications of effort with classification societies. The Note advises on ACS requirements for relevant organisations.

The Note makes the point that the MCGA will still exercise control and employ its powers to deny or revoke certification where this proves necessary.

May 2007

MIN 298 (M+F) SAFETY OF NAVIGATION (AIS)

MCA monitoring has revealed that some AIS systems have been found to transmit 1193046 as an incorrect MMSI. These may be accounted for by incorrect set-up or system default where mains and battery failure coincide.

This Information Note specifies how remedial action can be taken. It lists the equipments likely to transmit error signals in default mode.

January 2007

MIN 290 (M+F) AIS ACCURACY

This Information Note is addressed to manufacturers and operators, warning that the MCGA has 'continued to receive reports of vessels transmitting incorrect AIS data.'

The Note warns of consequent dangers to navigation and the potential to destroy trust in the AIS system. It gives details of the types of errors and their probable causes.

MRCC will attempt to contact vessels by VHF DSC or voice where they suspect data is incorrect or missing and other authorities are encouraged to do so. Other AIS users are urged to report detected deficiencies to the local MRCC.

If the identified problems are not corrected, reports will be made to the appropriate Port State Control Authority.

July 2007

NB: An article in Issue 15 of CHIRP (Confidential Hazard Information Reporting Procedures) Feedback has comments under the heading 'AIS Data Irregularity.' It says a number of reports have been received and gives details of one of them. It ends with a comment from a master who specifies that the AIS should be reset at the beginning of each watch. MARITIME MISCELLANY

IMO GMDSS MANUAL

The IMO has issued a completely revised comprehensive handbook on the GMDSS system – The GMDSS Manual 4th Edition. It is intended to replace the existing GMDSS Handbook. Details may be had on the IMO website:

CADETS BOOST

The highest number of trainees in years has enrolled in maritime courses at Fleetwood, Glasgow, South Tyneside and Warsash. This accounts for the large number of posts for maritime specialists being advertised in the educational and technical press.

GLA RADIO NAVAIDS PLAN

The General Lighthouse Authorities of the UK and Ireland (GLA) have published a report on radio aids to navigation. Entitled '2020 The Vision' it sets out GLA plans in respect of the radio navigation aids: GPS, Galileo, DGNSS, AIS, eLoran and racons.

It is a quite interesting range through the various systems, spelling out their likely future impacts on the navigation of vessels and the GLA intentions.

SEAWAYS ARTICLES

'Seaways' is the Journal of the Nautical Institute and your centre library should have a subscription. There were two interesting articles in the September 2007 Edition.

The first was by Professor David Last, President of the Royal Institute of Navigation. Professor Last points up the weaknesses in global navigation systems, including interference by tv harmonics. In summary he suggests a combination of GPS and enhanced Loran.

Professor Last points out that it is not surprising that a GNSS signal is subject to interference if it is no more powerful than a car headlight and is shared over half the earth's surface.

In the same Issue, Dr. J. Januszewski of the University of Gdynia compares different satellite systems, GLONASS, GALILEO, COMPASS GPS and regional systems such as those in India and Japan. He comments on attempts to search for compatibility between various systems.

Both articles are an interesting read - Ed

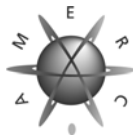
